Flood Plain Report - Jim Martinez, Public Works Dept., COSF

- Research is done, FEMA recommends getting grants.
- Need an elevation certificate from each homeowner.
- Hire a surveyor as a group to get work done (request certificate to determine where the lowest point of home structure is located.
- Each resident should ask their mortgage lender about a reduction in flood cost.
- They have been setting out beaver traps; should be completed by the end of week. They have been trapping beavers and releasing them in other areas for a couple of months.
- In the next few days, contractors should breach the dam.
- This is a federal project and they do not want outside department to touch the flood plain projects.
- Most homes are built post flood plain delineation. However, Wexwood Glen was built preflood plain delineation.


## Director of Code Enforcement - Brian Morris

- They are property police. Focused on quality of life.
- Department governs 90 plus square miles. Look for properties with tall grass, cars on grass and junk vehicles.
- Complaints can be submitted by calling 470-552-4311 or go to www.clickfix.com.
- When complaints are received, they will be checked out within 24 hours. The surrounding area will be surveyed, and information put into the database.
- The owner will be notified and expected to comply within a certain amount of time.
- If the owner does not comply with the complaint, the Code Enforcement board may go to court to settle the complaint.
- There is a Blighted Property Program that can take action to eliminate properties. They are very careful not to violate someone's property rights.
- There is an influx of investors. Many properties are purchased by hedge funds and are hard to reach. Code Enforcement tries to send a message concerning compliance when properties are neglected.
- Commercial Vehicles in residential area: Certain vehicles are not allowed because they impact the road, i.e., dump trucks, U-hauls, 18 wheelers, box trucks. RVs cannot be on grass.
- Loose dogs are not managed by Code Enforcement. Outsourced to Fulton County Animal Control, 404-613-0358.
